The purpose of this correspondence is to submit to the United States Environmental Protection Agency (USEPA) a request to withdraw its Demonstration for a Site-Specific Alternate Deadline to Initiate Closure in accordance with 40 CFR 257.103 that was based on a Demonstration for No Alternative Disposal Capacity submitted to USEA on November 30, 2020.

Dear David,

Thank you for your emails that notified EPA that the South Ash Pond 2, the unit covered by the CCR Part A demonstration submitted under 40 C.F.R. § 257.103(f)(1) for Will County Generating Station, ceased receipt of waste on December 12, 2022. As a consequence, Midwest Generation, LLC requested to withdraw the submitted demonstration from EPA review.

EPA reviewed the demonstration and determined that it included the required information, analyses and documentation specified under 40 C.F.R. § 257.103(f)(1), and consequently determined on January 11, 2022 that the demonstration was complete. As a consequence, the deadline for the South Ash Pond 2, the CCR unit covered by the demonstration, to cease receipt of waste was tolled throughout the entire period between April 11, 2021 and December 12, 2022, when the unit ceased receipt of waste. See, 40 C.F.R. § 257.103(f)(3)(ii).

Accordingly, EPA will updated the PART A webpage (<u>linked here</u>) to show that you have ceased receipt of waste, and that EPA will conduct no further review of the demonstration.
